- Section Township Range - Florida is divided up into Survey Townships and Sections. A survey township is identified by two numbers, a "township" number designating distance north or south from a designated line, and a "range" number denoting the distance east or west from a defined meridian. Survey Townships are then split into sections. Townships cover 36 square miles. That’s still a pretty big area, so townships are broken down even further. Each township of 36 square miles is divided into 36 sections, meaning each section of the township measures 1 square mile. Please visit [Florida Parcels](#) for further information.
- **Planning and Growth Management** - In general, a land use designation is given to describe the way a property is permitted to be used, such as residential, commercial, or industrial. However, understanding and interpreting the meaning of the Land Use designations is not simple or easy to absorb briefly. As a result, these category definitions are typically used by specialists and professionals in the developer community.
